In particular, the Anti-Bribery Policy of GOLDCHEM LTD:

- ✓ aims to comply with the applicable anti-bribery legal and regulatory framework
- ✓ seeks to understand the definition of corruption and its forms
- ✓ seeks the vigilance of employees and any person liable to identify actions related to bribery
- ✓ is suitable for the provision of services
- ✓ provides the framework for setting, reviewing and achieving anti-corruption objectives
- ✓ encourages the confidential reporting of any incident or suspicion of bribery through the specific means of communication and the vigilance of employees and associates to identify actions related to bribery based on trust, without fear of retaliation, giving them the opportunity to also contact Transparency International Greece via email <u>compliance@goldchem.gr</u>
- ✓ meets the requirements of the anti-bribery management system in accordance with ISO 37001:2016 and aims at the continuous improvement of the system
- ✓ encourages the company's employees to report any kind of relationships with Public Officials or Suppliers/Associates of the company.
- ✓ applies the principle of independence of the anti-corruption compliance function
- ✓ explains the consequences of non-compliance with the anti-bribery policy
- ✓ is committed to checking GOLDCHEM LTD's compliance with the legislation governing its activity
- ✓ leads to financial and non-financial audits internally in its operations.

The Policy is binding on all Employees, Members of Management, Business Partners, Financial Advisors, Legal Advisors, Suppliers, Subcontractors and any other third party acting on behalf of the company without any exception. In the annual review by the Management, compliance with this Policy is reviewed.
